TERMS & CONDITIONS

I understand that to be eligible for the Hudson Valley Gingerbread Competition at Mohonk Mountain House; I must agree to the following as indicated by my signature below:

- 1.) I must return my entry form by Email or fax, no later than 5pm on Friday, November 10, 2023. Entries are accepted on a first come basis and once we have filled the available spots registration will be closed, which may occur prior to the entry deadline.
- 2.) I must deliver my completed entry to Mohonk Mountain House on Sunday, December 10, 2023, at the time frame I am assigned one week before the competition date.
- 3.) I must follow all of the Rules and Procedures set forth by Mohonk Mountain House.
- 4.) My entry is selected it will remain on display during Mohonk Mountain House's holiday season through Monday, January 1, 2024. If I refuse to leave my entry and I am a winner I forfeit my prize in its entirety.
- 5.) If my entry is not selected to be displayed I must pick up my entry after judging on Sunday afternoon, December 10, 2023 or by 5:00pm on Monday, December 11, 2023. If my entry is selected for display then I must pick up my entry between the hours of 9:00am and 5:00pm on Tuesday, January 2, 2024. Entries not picked up will be discarded the morning of Wednesday, January 3, 2024.
- 6.) Permission is hereby granted to Mohonk Mountain House to print or otherwise duplicate the picture or likeness of my entry and/or myself with my entry for either internal or external release, this includes print and online publications, plus local and network television. I understand that the image of my entry becomes the property of Mohonk Mountain House. Permission is also granted to Mohonk Mountain House to transport my entry for publicity purposes while understanding that at no time does Mohonk Mountain House guarantee the safety or security of my entry and cannot be held responsible for any damages incurred to my entry on or off the resort's property.
